#### **Promotional Period for Introductory APR:**

The Introductory APR for balance transfers and cash advances will apply to transactions posted to your account during the first two months following the opening of your account. Any existing balances on Vibe Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

#### **Effective Date:**

For California Borrowers, the Visa Platinum and Visa CashRewards are secured credit cards. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

#### Late Payment Fee:

#### Cash Advance Fee (Finance Charge):

4.00% of each cash advance. However, this fee is waived after the promotional period as stated in the Promotional Period for Introductory APR.
