#### **Promotional Period for Introductory APR:**

Any existing balances on Vibe Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

#### **Effective Date:**

##### Cash Advance Fee (Finance Charge):

4.00% of each cash advance. However, this fee is waived after the promotional period as stated in the Promotional Period for Introductory APR.
